# FISCAL OFFICER'S BUSINESS

RESOLUTION 9-5-23-1: The Board of Trustees of Bath Township, Allen County, Ohio hereby accepts the resignation of Jerod Wright as an intermittent fire department employee effective August 30, 2023. Motion made by Mr. Meeks seconded by Mr. Hollinger and passed by roll call vote.

RESOLUTION 9-5-23-2: The Board of Trustees of Bath Township, Allen County, Ohio hereby moves to adopt the following resolution:

RESOLVED, by the Governing Board of BATH TOWNSHIP, Allen County, Ohio, in accordance with the provisions of law has previously adopted a Tax Budget for the next succeeding year commencing January 1st, 2024; and

## CORRESPONDENCE

Received confirmation letter from the Auditor's Office verifying that recently requested appropriation changes for the principal loan payments to the Ohio Public Works Commission and changes for making 2022 road program payments do not exceed the official estimate of resources available.

Received schedule of estimated 2024 payments from Local Government funds from the Auditor's Office. Bath Township is estimated to receive \$94,814.38 in Local Government funds in 2024.

Received a letter from the Office of the Allen County Prosecutor regarding legal updates that were recently made by the general assembly regarding competitive bidding and zoning referendums as detailed in HB 33. The changes go into effect on October 3rd, 2023.

Received a letter from the Office of the Allen County Prosecutor regarding ARPA funds. This letter serves as a reminder heading into audit season that all ARPA purchases must be made in compliance with state and federal laws. It is the recommendation of the Prosecutor's Office to seek outside counsel for these matters.

Received a letter from the Ohio Department of Transportation regarding SR 81/Thayer Road Intersection Improvements. This letter is an invitation to a public meeting to discuss converting the intersection to a roundabout. The meeting is scheduled for Thursday, September 21st, 2023, from 1-3 PM or 6-8 PM at the Union Chapel Missionary Church, 4869 Ada Road, Lima.
